

Unresolved Case: The Erasure of a Patient's Unnatural Death through Coordinated Institutional Actions (Japan)

Overview

This archive documents an unprecedented unresolved case in Japan in which the unnatural death of a patient that occurred inside a hospital was jointly erased by relevant institutions and treated as if it had never existed.

The materials presented here indicate that medical procedures were carried out without an intent to treat the patient, and that the patient's clinical course was deliberately directed toward death. Following the death, the hospital, police, and administrative authorities acted in coordination to substitute the cause of death from an unnatural death to a natural death, thereby eliminating the incident from official records and effectively erasing its existence.

What Happened

A Patient Death Inside a Hospital

- The patient underwent cardiac catheterization for myocardial infarction and sustained multiple severe injuries related to the procedure—injuries that would not ordinarily occur under standard medical practice.
- The physician did not disclose these injuries to the patient or the family and did not initiate life-saving measures, including emergency transfer to cardiovascular surgery.
- As the inevitable consequence of this deliberate inaction, the patient died.

The core issue is not the occurrence of procedural injuries themselves.

The core issue is that injuries caused by medical intervention were deliberately left untreated, resulting in the patient's death.

Fabrication of the Cause of Death and Erasure of the Incident After Death

- The patient's family requested a judicial autopsy.
- A police officer informed the family that a judicial autopsy had been conducted and that no findings indicative of injury related to medical intervention or criminal involvement had been identified, and provided a document described as an autopsy report.
- The same explanation was later given by a forensic medicine professor and by attorneys consulted by the family.
- Subsequent verification by the family revealed that an official death certificate had, in fact, been issued by the hospital.
- This indicates that the patient's death was substituted from an unnatural death to a natural death.
- It is not possible for both a death certificate and a judicial autopsy report to simultaneously exist as official documents certifying a single death.
- The purported autopsy report was later determined to be fabricated, as it consisted of a copied A4 sheet lacking the standard death notification section.

Through these coordinated actions by the hospital, police, forensic medicine personnel, attorneys,

and administrative authorities, the major incident that occurred inside the hospital was erased and treated as if it had never existed.

Actions Taken by the Family

- The family consulted multiple attorneys; all either denied the family's account or remained silent.
 - Requests for investigation were submitted to dozens of domestic media organizations through various means, including email, postal mail, and telephone, but no responses were received.
 - Additional efforts, including the publication of a disclosure website and dissemination via social media, proved ineffective.

Why Independent Review Is Required

- This case represents an unprecedented unresolved incident in which a major patient death that occurred inside a hospital was jointly erased by the hospital, police, forensic professionals, attorneys, and administrative bodies.
 - Despite exhausting all available avenues within Japan, no independent investigation has ever been conducted, indicating a high likelihood that domestic oversight mechanisms have failed to function.
 - For these reasons, the family has decided to request independent review by international institutions.
 - I believe this case reflects a broader issue in Japan's medical and legal systems that urgently needs public scrutiny.
 - If examined, this case has the potential to raise broader questions regarding freedom of expression, freedom of the press, and the protection of victims' human rights in a democratic society such as Japan.
